The ISGH Rental Agreement for the Gymnasium

This Rental Agreement made this _____ day of _____, 20____, by and between THE ISLAMIC SOCIETY OF GREATER HARRISBURG, a not-for-profit corporation, hereinafter called "ISGH" and _____, hereinafter referred to as "Renter",

WITNESSETH: That ISGH hereby rents the ISGH gymnasium, together with parking facilities contiguous thereto said premises, to be used for the purpose of _____

_____ at which not more than _____ persons will be in attendance.

The term of this possession of the premises shall begin at _____ o'clock ____ m. on the _____ day of _____, 20____, and terminate at _____ o'clock ____ m. on the same day. Renter agrees to pay ISGH \$200.00 for a 5 hour rental and an additional \$50.00 for the use of the Kitchen for the total sum of _____ dollars for use of the facilities.

ISGH acknowledges the receipt of a security and damage deposit of \$100.00, which will be deposited into the ISGH account. Refund of deposit is contingent upon damage inspection. If the event is cancelled, ISGH must be notified 7 days in advance of the event date for Renter to receive a refund of the deposit.

This Agreement will become void if premises are destroyed or so damaged as to be unusable for the event. Any monies paid will be returned.

Renter covenants and agrees with ISGH as follows:

1. No alcohol on premises. No smoking in the building, only at designated areas outside.
2. No music or dancing on the premises.
2. Take care of the premises and keep them from filth, danger of fire or any nuisance.
3. Do not sublet or allow any other user to come in under Renter or assign this agreement to any part thereof.
4. Comply with the Ordinances of the Borough of Steelton and the laws of the State of Pennsylvania and hold ISGH harmless of all charges of damages for non-observance thereof.
5. Do not put upon premises any signs or billboards or advertisement without permission by ISGH.
6. Pay ISGH for any damages to the premises due to the Renter's use that exceeds the deposit. The deposit shall be retained by ISGH to offset damage caused by the renter. Portions of the deposit remaining after repairs are made may be returned.
7. Renter shall hold harmless ISGH against all claims arising from any accident, injury, or damage to any person or property occurring during the rental period.
8. Renter shall similarly hold harmless ISGH against any penalties, damages, or charges imposed for any violation of any law, statute, or ordinance occasioned by Renter or those participating in the event.
